

**TOWN OF GRANUM
PROVINCE OF ALBERTA
BYLAW 2011 - 04**

A BYLAW OF THE TOWN OF GRANUM IN THE PROVINCE OF ALBERTA BEING A BYLAW OF THE MUNICIPALITY OF THE TOWN OF GRANUM IN THE PROVINCE OF ALBERTA TO REGULATE SNOW AND ICE REMOVAL.

WHEREAS the Council of the Town of Granum considers it desirous to have sidewalks cleared of snow and ice within a reasonable time.

AND WHEREAS the Town of Granum proposes to pass a Bylaw regulating snow and ice removal on sidewalks.

TITLE:

This Bylaw may be cited as the Town of Granum Snow and Ice Removal Bylaw.

DEFINITIONS:

1. **In this Bylaw:**

- (a) **Town** means the Town of Granum in the Province of Alberta or the area contained within the corporate boundaries of the Town.
- (b) **Sidewalk** means that part of a roadway primarily intended for the use of pedestrians and excludes the grassed boulevard.
- (c) **Bylaw Officer** means the Bylaw Officer of the Town of Granum.
- (d) **Tag** means any ticket or tag, which is authorized by the Bylaw Officer in which a penalty may be paid out of court in lieu of appearing to answer a summons.
- (e) **Notice** means a warning from the Town of Granum to remove snow or ice within a 24 hour period.
- (f) **Fine** means any ticket or tag which is authorized by The Town of Granum and issued by the Bylaw Officer.

SPECIFIC REGULATIONS


- 1. The owner or occupant of any premises abutting a **sidewalk** shall clear away any snow or ice from the front and flank of the abutting **sidewalk** within FORTY-EIGHT (48) HOURS after the time such snow or ice was deposited or formed on the **sidewalk**.
Snow or ice shall be deposited on the owner/occupant's property or on the boulevard adjacent to the owner/occupant's property.
Snow or ice shall **not** be deposited on to the roadway.
Sidewalks along Railway Avenue are exempt, snow and ice may be deposited on to the Avenue

4. If the **Town** removes the snow and ice off the **sidewalk**, or removes **deposited** snow off the **roadway**, it will be at the owner or occupant's expense. Actual costs vary depending on the length of the **sidewalk** /and the amount of snow or ice to be removed. Cost of the **Town** removing the snow and ice will be charged to the owner or occupant and any costs incurred by The **Town** plus 20%. Costs shall also include staff time and material used and availability of staff. If payment is not made for the costs involved the amount of the billing shall be added to the property tax account of the owner and shall form part of the unpaid tax of the property and shall be subject to all penalties as if it were taxes owing.
5. It is the intention of Council that each separate provision of this Bylaw shall be deemed independent of all other provisions and if any provision of this Bylaw were declared invalid, that all other provisions shall remain valid and enforceable.
6. Schedule A forms a part of this bylaw.
7. Bylaw # 2010-08 is repealed upon passage of this bylaw.
8. This Bylaw shall come into full force and effect on the day of 2011.

READ A FIRST TIME this 28 day of Nov. 2011.

READ A SECOND TIME this 12th day of December 2011.

READ A ^{third} ~~SECOND~~ TIME AND FINALLY PASSED this 9th day of Jan 2012
